



## Promotion 360d@OUMF

The OUMF festival and Desjardins 360d offers you the chance to have \$50 in your pocket! Read the rules below to find out how to access it.

### Conditions

#### PROMOTION PERIOD

The 360d@OUMF promotion is organized by the Fédération des caisses Desjardins du Québec (the "Organizer") and will run from 9:00 a.m. on May 18, 2019, to 5:00 p.m. on September 17, 2019 (the "Promotion Period").

#### ELIGIBILITY

This promotion is open to:

- Students who are Quebec or Ontario residents between 18 and 30, and not a member of a Desjardins caisse in Quebec or Ontario.

#### Exclusions

The following people are not eligible for the promotion:

- a. Employees, executives, directors and officers of the Fédération des caisses Desjardins du Québec, the Fédération des caisses populaires de l'Ontario Inc., the Fédération des caisses acadiennes, their member caisses or any other Desjardins Group entity, their immediate family members (siblings, children, parents), their legal or common-law spouse or any persons residing with them.

#### HOW TO PARTICIPATE

In order for participants to be eligible for the promotion and for a referral to be considered eligible, all of the following conditions must be met:

- I. The referred person must be 18–30 years old and must not have any Desjardins accounts (in Quebec or Ontario). They must have been referred by SQDL. They must mention the "360d@OUMF" promotional code between August 1, 2019 and September 30, 2019 (the "Eligible Participant").

- II. The Eligible Participant must open an account at a Desjardins 360<sup>d</sup> centre at UQÀM, Concordia University or Université de Montréal.
- III. The Eligible Participant must not have been referred by another UQÀM student association. Referrals of Eligible Participants by other associations take precedence over this agreement (see Appendix B of the sponsorship agreement for the list).
- IV. The Eligible Participant must meet all the following conditions within 30 days of submitting the account opening application:
  - a. Open an account
  - b. Be eligible as a member
  - c. Meet one of the following requirements: (1) Sign up for a monthly transaction; or (2) Make a bill payment on Accès D.

### **Bonus**

Once it has been confirmed that the Eligible Participant has met all the conditions listed in the “How to participate” section,” the \$50 bonus will be deposited into their Desjardins account.

### **GENERAL CONDITIONS**

1. To receive the bonus, Eligible Participants must:

Confirm that they meet the eligibility conditions and other requirements herein.

The bonus will not be awarded in the event of non-compliance with the above-mentioned terms or any other conditions herein.

2. **Verification.** All entries and declaration forms may be subject to verification by the Organizer. Any entry or declaration form that is incomplete, inaccurate, illegible, mechanically reproduced, severely damaged, fraudulent or submitted late, or that contains an invalid telephone number or is otherwise non-compliant, may be rejected and will not entitle participants to the bonus.
3. **Disqualification.** Anyone who participates in or tries to participate in the promotion by any means that violate these rules or are unfair to other participants (e.g., software piracy, use of voting groups or false names) will be automatically disqualified and may be reported to the appropriate legal authorities.
4. **Promotion operation.** Any attempt to undermine the legitimate operation of this promotion constitutes a violation of civil and criminal laws. If such attempts are made, the Organizer reserves the right to reject the participant’s entries and obtain redress under the law.
5. **Acceptance of bonus.** Bonuses must be accepted as described herein and cannot, in any case, be transferred to someone else, in whole or in part, or be substituted for another bonus or redeemed for cash, except by decision of the Organizer, at its sole discretion.
6. **Limitation of liability.** If the Organizer is not able to award the bonus as described herein, it reserves the right to award a similar bonus of equal value or, at its sole discretion, to award the monetary value of the bonus indicated herein.

7. **Limitation of liability: Use of the bonus.** The Organizer and the persons on whose behalf the promotion is held cannot be held liable for any damages that may result from their participation in the promotion, or acceptance or use of the bonus. Participants acknowledge that upon receipt of the bonus, fulfillment of bonus-related obligations becomes the sole and exclusive responsibility of the various product and service providers.
8. **Limitation of liability: Promotion operation.** The Organizer and the persons on whose behalf the promotion is held cannot be held liable for any malfunction of any computer component, software or line of communication, the loss or absence of network communication, or any transmission that is faulty, incomplete, incomprehensible or deleted by any computer  
or network and which may limit or prevent any person from reading the promotion conditions. Furthermore, the Organizer cannot be held liable for any loss or damage that may be caused, directly or indirectly, in whole or in part, by any web page, software or other download or by the transmission of any information about participating in the promotion. More specifically, if the administration, security, impartiality, integrity or operation of the promotion is corrupted or seriously affected, namely because of a virus, bug, unauthorized intervention, alteration, fraud, technical computer failure or any other cause, the Organizer reserves the right to cancel, modify, extend or suspend the promotion without prior notice.
9. **Limitation of liability: Receipt of entries.** The Organizer and the persons on whose behalf the promotion is held are not responsible for entries that are lost, misdirected or late.
10. **Limitation of liability: Situation beyond the Organizer's control.** The Organizer and the persons on whose behalf the promotion is held cannot be held liable for any situation in which their inability to act results from an event or situation beyond their control, or a strike, lockout or any other labour dispute in the places of business of the organizations or companies whose services are used to hold the promotion.
11. **Promotion changes.** The Organizer reserves the right to, at its sole discretion, cancel, terminate, modify or suspend this promotion, in whole or in part, should any event or human intervention occur that could alter or influence the administration, security, impartiality or operation of the promotion as stipulated herein. The Organizer cannot be held liable should such an event or intervention occur.
12. **Termination of the promotion.** In the event that, for any reason whatsoever, participation in the promotion is terminated in whole or in part prior to the end date set out herein, bonuses may be awarded, at the Organizer's discretion, from among the eligible new member applications duly recorded and received up to the date of the event terminating participation in the promotion.
13. In no case shall the Organizer be required to award more bonuses or award a bonus other than in compliance with these conditions.
14. **Limitation of liability: Promotion participation.** By participating in or attempting to participate in the promotion, participants agree to not hold the Organizer or persons on whose behalf the promotion is held liable for any damages that may result from participating or attempting to participate in the promotion.
15. **Personal information.** All personal information obtained from participants will be used for promotion administration purposes only. No communications, commercial or otherwise, unrelated to this promotion will be sent to participants, unless they have otherwise agreed.

16. **Decisions.** Participants agree to be bound by these conditions and to the final decisions made by the Organizer administering the promotion.
17. If a section of this document is declared or deemed illegal, unenforceable or invalid by a court of competent jurisdiction, that section will be considered null and void, but all other sections that are not affected will be enforced to the extent permitted by law.

19. In the event of a discrepancy between the English and French versions of these conditions, the French version will prevail.
